Elections

2022 was an exciting year, holding three elections. Our new voting machine was successfully used for the first time in the Fall Primary, and again in the November General election. I want to thank and congratulate our wonderful election workers for the smooth operation of Aurora's polling place, as well as all the towns people who turned out in great numbers to vote, waiting patiently and cheerfully in line to cast their vote. There are two upcoming 2023 elections scheduled in April and November, each with a potential for an additional Primary. Of special interest is the April 4th spring election will include election of our town board positions: town chairman, (2) town supervisor positions, clerk, and treasurer. Watch the town bulletin board notices and website for caucus information. Additionally, I anticpate conducting Election Inspector training in the Fall of 2023 as both a refresher course and training new election workers for the 2024-2025 elections. If you are interested in becoming an election worker, please contact me as we need you! 2022 Road Report

The 2022 Road Budget was \$203,000, the largest budget the town has had to work with, due in part to money that was saved and set aside from the 2021 budget specifically for the 36th Road three-year rebuild project, knowing that it was going to be very expensive. The town spent roughly \$10,000 on snow plowing, sand and salt in 2022, which was down from the previous year. The town received \$104,000 in ARPA funds from the State of WI in the last two years. This money came with strict guidelines on what it could be used for. Thankfully, one was drainage. We had two major culverts fail in 2022, and each of these repair projects cost \$36,000 which were paid for with ARPA funds. We also applied ARPA funds towards the second phase of the 36th Road rebuild project, which totaled \$185,000 in 2022. The remaining road budget was consumed by roadside mowing, pothole patching, and other road patch work.

Chairman's Report

On April 4, 2023, all members of the town board are up for re-election. The town caucus will be held January 12, 2023, at 6:30pm, at the Aurora Town Hall. This is where you can come to be officially nominated for a position on the town board and have your name put on the April election ballot.

In 2023 the town will pay the Berlin Fire Department \$33,000 for fire and ambulance service, which includes the town's portion of the cost to upgrade their respirators. In 2025, we will also be helping to pay for a new firetruck. The town's estimated portion is \$105,000. We currently have \$74,000 in a CD for this upcoming expense, and will continue to add funds to the CD as our budget allows.

This past year Waushara County passed an ordinance to open all county highways to ATVs. During upcoming January, February and March town board meetings, the board and residents will address whether to open any town roads to ATVs, as well. This issue is being pushed by the area's ATV clubs, and your town board does want your input on this before we make any decisions.
