2020 was an interesting year for elections, but we made it through them smoothly due to the wonderful election workers I have and to the towns people who were paitent and worked through all the new rules with us. In 2021, we are going back to all paper ballots as we have to replace our current voting machines because the current machines will not longer be serviced. With the increase in absentee ballots the new machine will help the election workers process ballots quicker. Please be patient as we all figure out how to use it. The upcoming elections are in February (possibly not for our Township) and April 6 which will include the town board, clerk, and treasurer. The treasurer position will be open. Watch the notices and website for caucus information. The polling place for Town of Aurora is at the Town Hall located at W2319 State Road 21. Please visit https://MyVote.wi.gov to find out if you are registered and for more information on the elections and what you need to have with you to vote.

2020 Road Report

The 2020 Road budget for the Town of Aurora was \$162,000.00. Out of that comes our snow plowing which we have a contract with Retzlaff Motorsports LLC to do our plowing and sanding. We replaced two culverts this year, one on 31st avenue and one on Cypress avenue. This year we pulverized and repaved three quarters of a mile of Cypress avenue to the sum of \$130,00.00 which included shoulder work and some drainage work. We also had the brush sprayed on a portion of Waushara ST, 36th RD, Cypress DR, and Cumberland Ave. Last year the Township purchased its own roadside mower, so we were able to mow the roadside twice this year. It also made it more flexible in timing and allowed us to do a better job at cutting back more of the brush in the right of way.

Chairman's Report

As 2020 comes to a close, I want to recognize our town clerk, Katie Reinbold. She has done an amazing job with both spring and fall elections. From coming up with ideas to keep everyone safe, heathy, and socially distanced, to keeping up with all the absentee ballots. Normally the town has about 10 for a major election, this year she handled over 150 absentee ballots. On top of that, keeping up with the ever-changing rulings that where coming down from local and federal courts. On top of all of that and her normal duties she was also able to secure a grant from the state of Wisconsin for self-dispensing units for the town hall and the remaining money will be use for the Berlin ambulance short fall. In 2019 the short fall was in the neighborhood of \$11,000.00.

This coming January we will be starting the election process for the town board. We are all are up for reelection in April. On January 14 at 7:00 pm a caucus will be held to see who will be on the ballot in April. Unfortunately, our treasurer has decided to not seek reelection so if anyone is interested in this position please contact Katie or myself.
