2021 was a quiet year for elections and we only had 2 at the beginning of the year. 2022 will have 3-4 elections and we will finally be impletmenting the new voting machine. We will be moving back to paper ballots that will feed into the machine. I am planning on having an open house for anyone interested to view the new machine. 2021 Road Report

2021 was a productive year for road repairs. Our snow plowing costs where down a little bit which freed up our budget for more road maintenance. We spent \$15,000 on snow plowing and \$3,000 on roadside mowing. This summer, we had two culverts fail one on Waushara St and one on Riverdale Dr. Each culvert from start to finish cost around \$6,000. A portion of Cumberland Ave was seal coated and a section of 36th Ave was crack filled at a cost of \$20,000. We also stared a three year rebuild project on 36th Road. It has included: some drainage work, three new culverts, and adding more gravel base to the roadbed and shoulders, which allowed for a wider blacktop surface than what the road was before. These three quarters of a mile alone cost \$127,000, hence why the board felt it should be done over three years so we could to it correctly without having to borrow money. Our plan is to do another portion of 36th this coming year. Yes, if you add all this up, we spent \$177,000 on roads this past year; that's the most we have spent on roads in a very long time if not ever.

Chairman's Report

Over the past two years the town has been working with the City of Berlin regarding our Ambulance service. Moving forward, our ambulance service will continue to come out of Berlin. The board feels it is still the best choice for the best service for the town and it does come with a cost of around \$35,000.00. This may change in the future as Waushara County is still talking about building an ambulance station closer to the township. At that time, we will revisit our options. To better serve you physically and financially.

The other agenda item that has been on the meetings this past year is the ATV's. The board is exploring different ideas and routes for the township. The main idea is one route through the town that crosses Highway 49, but many concerns have been brought up about the safety of that intersection. The other thing that I see as a possibility with ATVs and town roads is they will be open to town residents to use to get to a route. The few meetings that ATV routes have been on the agenda, the board has gotten very little feedback from the town's residents. This is being pushed by the ATV clubs in the area and your town board does want your input on this before we make any decisions. Please reach out to me at 920-237-9919 with your opinion.
